This is a Release of Liability

I or we understand that the hazards of outdoor recreation, include, by way of example and not by limitation, the following: loose or crumbling rock; ice or snow hazards; improper rope technique/management; improperly tied harnesses, knots, crampons or ski bindings; weather considerations and hazards; ice fall, rock fall or other falling debris; falling onto a ledge or other protrusion. I or we understand that rescue may not be available and even if available may fail or be slow. I or we understand that there are more hazards than enumerated here, and that there are unknown and unforeseeable hazards.

I or we understand that though **Golden Bell Camp and Conference Center** has the expertise and foresight to purchase, maintain and replace outdoor equipment towards the highest margins of safety no such equipment or situation is infallible. I or we agree to replace at full retail value any unreasonable loss, damage or destruction to **Golden Bell Camp and Conference Center** equipment and/or property.

I or we engage freely in the activities led by Golden Bell Camp and Conference Center. I or we accept and clearly agree to participate at our own risk.

Though I or we realize that **Golden Bell Camp and Conference Center** operates to the highest standards of safety, I or we therefore, for myself (ourselves), heirs, successors and representative hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, AND AGREE TO INDEMNIFY, HOLD HARMLESS AND DEFEND the employees, officers, directors and owners of **Golden Bell Camp and Conference Center** from any and all liability for any and all such damage, injury, paralysis or death to myself (ourselves) or any other person or property. I or we are accepting for myself (ourselves) the full responsibility for any and all such damage, injury, paralysis or death results from the NEGLIGENCE of **Golden Bell Camp and Conference Center** staff or associates or their estates or some other cause. I or we further agree for myself (ourselves) my (our) successors, heirs, and family not to sue **Golden Bell Camp and Conference Center** its instructors, examiners, employees, officers, directors, agents, assignees for participating in this or any other **Golden Bell Camp and Conference Center** program, or in connection with any other event taking place including transportation/travel or situations of any kind.
